We are seeking one or more artists to submit creative proposals to inspire and delight patients, visitors and staff in clinical areas of the new Murrurundi Wilson Memorial Hospital.

Artists should register by attending a site briefing at 2pm on Tuesday
15 September and rsvp by 11 Sept. to email brigette.uren@health.nsw.gov.au

Selection process

- 1. Submit your artistic response as a PDF file with the entry form, making sure you meet the criteria in FULL to be eligible.
- The selection panel will include representatives from the project's Community Reference Group who will assess submissions and create a shortlist of finalists for final endorsement by the Local Health District and Project Team.
- 3. Selected artist/s will be notified in October.
- 4. Artwork/s will be installed in the new Hospital in November 2020.



Expression of Interest (EOI)

Purpose

To embed the hospital as valuable to civic and district life, reflecting community stories, heritage and future aspirations; and

To provide an atmosphere that is calm, uplifting and hopeful.

Location

There are two key areas of the new Murrurundi Wilson Memorial Hospital for the display of these works in both patient corridors (refer site plan attached). Selected artworks will complement these areas.

Brief

- To provide an uplifting artistic response relevant to the Murrurundi landscape, complementary to interior design and architectural commitments for positive staff, patients and visitor wellbeing;
- Consideration should be given to patient experience, as well as staff and visitors and the range of emotions experienced in health settings;
- Artwork/s must be 2-D due to the limitations of the display area. They may of any genre; paint, photograph, etching, mixed media etc;
- The total linear meters available for display is 10 metres and 14 metres (two corridors), however is not continual due to building elements such as doors, signage, handrails and other elements;
- All works submitted for the EOI must be original works created by the person who is entering the EOI;
- Artwork/s older than 3 years are not eligible.

Conditions of Entry

- Site briefing: not mandatory, however encouraged for you to experience scale and technical details.
- Images and artist statement will respond to the core aims of arts integration noted above.
- The application form must be completed in full to be eligible.
- Selected artworks may be framed to meet infection control standards. The artist is NOT required to provide the frame.
- The Hospital reserves the right to place images on social media or electronic media throughout the Hospital.
- Selected images will be attributed to the artist/s
- The greatest possible care will be taken of all image files received but no liability will be accepted for loss or damage.
- Images will not be returned to the applicant unless by prior arrangement.
- The decision of the selection panel regarding the selected artist/s will be final.
 In the event of any other dispute, the ruling of the Health Services Manager shall be final.
- There is no entry fee to enter the EOI, nor will fees be paid to applicants for their time or use of images or other related costs to enter the EOI.
- The selected artist/s will receive \$5000 +GST (if applicable), per corridor, payable upon tax invoice.
- If more than 1 artist/corridor is submitted as a group display, the fee will be equally distributed payable upon tax invoice.
- We reserve the right not to proceed with this EOI without prior consultation.
- Selected artist/s will enter an MOU to complete the work/s.

Selection criteria

- The Murrurundi Wilson Memorial Hospital Redevelopment Art Commission is open to artists who are living or working in the Upper Hunter Shire I GA.
- Artistic excellence creative response to the brief and storytelling capacity of the artwork/s.
- Audience impact the ability of the proposed works to be intergenerationally relevant.
- Legacy the capacity of the artwork to withstand time, quality of materials and with limited maintenance scheduled.
- Operational impact artist's CV demonstrating ability of the artist to work within finite time and budget constraints.
