## HAY HEALTH SERVICE REDEVELOPMENT

Call for Expressions of Interest (EOI) FROM ABORIGINAL AND TORRES STRAIT ISLANDER CREATIVES/ARTISTS



Located on the lands of the Wiradjuri and Nari Nari People, the Hay Health Service Redevelopment (the Redevelopment) is being delivered as part of the NSW Government's \$297M Multipurpose Service Program to provide health and aged care services for small and remote rural communities.

This health facility upgrade means it will meet the community's healthcare needs as the population ages. The Hay Health Service is a part of the Murrumbidgee Local Health District.

Artists/creatives are invited to provide a creative response to Country and a sense of a warm welcome to Wiradjuri and Nari Nari mobs, the Traditional Custodians of the land, past, present and future, also acknowledging the contemporary Hay community and the many Aboriginal and non-Aboriginal families seeking care.

The newly commissioned work will be hung in the Hay Health Service Reception area.

#### **Selection Process**

1. Submit your completed EOI form, making sure you have provided all information including examples of previous works.

2. EOIs will be reviewed by the Selection Panel comprising representatives of the Redevelopment Team, Hay Health Service and two delegates from the Aboriginal community. An Artist will be selected to undertake the commission.

3. The selected Artist will be notified by 31 May 2021 and undertake the work in accordance with Terms and Conditions below.

4. The work will be completed and installed in the Hay Health Service by 30 July, 2021.

## **Selection Criteria**

The Artist will be selected based on the below criteria, and be invited to submit a design proposal. The selected artist will demonstrate:

1. Artistic excellence (please submit 200 words on what you think the artwork themes should relate to)

2. Experience (please submit CV and examples of previous work)

3. ABN/insurances (to enable payment)

4. Installation and maintenance: artwork/s should be low maintenance, meet infection control standards and not disrupt capital or operational program

## Artist Fee

Artists will be paid not more than \$2500 +GST (if applicable) for all components of this commission, inclusive of community consultation, materials, travel, delivery and ancillary costs associated with the artwork.

## **Design Considerations**

1. Artists are invited to provide a creative response to Country and a sense of warm welcome to Wiradjuri and Nari Nari mobs, the Traditional Custodians of the land, past, present and future, also acknowledging the contemporary Hay community and the many Aboriginal and non-Aboriginal families seeking care.

2. Works made on Country with community is a high priority.

3. The newly commissioned work will be hung in the Hospital Reception area. Suggested dimensions are 1800mm x 1100mm.

4. Installation & Maintenance: Artwork must comply with hygiene standards and consider maintenance schedules.

5. The commissioned work will need to consider the appropriate selection of materials and design details for a hospital environment.

Design details and material choices therefore need to be hygienically appropriate and be able to withstand regular clinical cleaning. While material selections and approaches are open, these choices will need to be identified by the selected Artist, and final material decisions are to be agreed with the Redevelopment Team.

## **Project Timeframe**

- 24 May 2021- EOI evaluation and selection
- 31 May 2021 Successful artist notification
- 18 June 2021 Artist concept submitted
- 25 June 2021 Artist concept approved
- 26 July 2021 Final completed artwork accepted
- 30 July 2021 Artwork/s installation

#### **Terms and Conditions**

a. By submitting an EOI, Artists accept the Terms & Conditions associated with the commission.

- b. The Murrumbidgee Local Health District reserves the right to place images on social media.
- c. Selected artwork/s will be attributed to the Artist/s.
- d. The artwork will be displayed in a location as determined by the Project team.
- e. The EOI/s must be accompanied by the application form in full.

f. The artwork will respond to the core aims of the brief, to provide a creative response to Country and a sense of warm welcome to Wiradjuri and Nari Nari mobs, the Traditional Custodians of the land, past, present and future, also acknowledging the contemporary Hay community and the many Aboriginal and non-Aboriginal families seeking care.

g. All examples of previous works submitted for the EOI must be original works created by the person who is submitting the EOI. The decision of the Selection Panel regarding the selected artist will be final. In the event of any other dispute, the ruling of the Health Services Manager shall be final.

h. There is no entry fee to submit the EOI, nor will fees be paid to applicants for their time or other related costs to submit the EOI.

i. The selected Artist/s will receive \$2500 +GST (if applicable), payable upon tax invoice. Artists working as a collective will be commissioned as a single team with a tax invoice to be paid to the team not exceeding \$2500 + GST (if applicable)

j. We reserve the right not to proceed with this EOI without prior consultation.

k. Late entries will not be accepted.

I. Prior to final installation of the artwork, the artist must obtain approval from Murrumbidgee Local Health District.

m. For any material independently created for the Art Commission, the right, title and interest in copyright and other intellectual property rights of the material will vest on creation in the Artist (who must make available that material on request, to the other party).

n. Copyright

i. Artist/s own the copyright of their work.

ii. The Artist gives non-exclusive rights to Health Infrastructure and Murrumbidgee Local Health District to publish the artwork on social, print and other media as appropriate.

iii. The participant will grant Murrumbidgee Local Health District permission to reproduce, publish, or display the image of the work online (including media) or in publications and for printing to display.

iv. Artwork might also be shown in electronic media across Murrumbidgee Local Health District or printed on large murals.

v. All necessary attribution will be made.

vi. Use of the artwork by the artist shall attribute the Murrumbidgee Local Health District, subject to separate agreement.
